

Salary Board  
Monthly Minutes of the  
Lancaster County Salary Board  
February 2, 2026

The meeting was called to order by Commissioner Ray D'Agostino at 1:30 p.m. in the Commissioners Conference Room 701, 7th Floor, at the Lancaster County Offices, 150 N. Queen Street.

Members Present: Commissioner Ray D' Agostino, Commissioner Joshua Parsons, Commissioner Alice Yoder, and Deputy Controller Kathy Kunkel.

Others Present: President Judge Leonard Brown III, Carly Galura, Larry George, Christina Peddigree and Jackie Pfursich.

Note: there were others present who did not sign in and whose identity is unknown.

Commissioner Yoder moved to approve the minutes of the January 12, 2026 meeting. Commissioner Parsons seconded. The motion carried unanimously.

President Judge Leonard Brown III, requested approval to reclassify and post one vacant Court Liaison Staff Attorney position (600014), Grade R, to Grade U, effective upon salary board approval. (Min: \$80,769 Mid: \$100,971 Max: \$121,153.50). Following discussion, President Judge Brown moved to approve. Commissioner Yoder seconded. The motion carried unanimously.

Deputy Controller Kathy Kunkel requested approval to hire an applicant at an annual salary of \$55,500 which is above the start rate for an Accountant/Auditor position (500196), Grade L, effective February 2, 2026 (Min: \$52,065 Mid: \$65,091 Max: \$78,117). Following discussion, Deputy Controller Kunkel moved to approve. Commissioner Yoder seconded. The motion carried unanimously.

Anne Cooper, Register of Wills, requested approval for a temporary 5% salary increase for employee, due to assuming additional duties for position 501017, effective December 10, 2025, until March 3, 2026, or until the incumbent returns to duty. Following discussion, Ms. Cooper moved to approve. Commissioner Yoder seconded. The motion carried unanimously.

Christina Peddigree, Human Resources Director, requested approval to amend the 2026 position complement list as approved at the December 2025 Salary board meeting to include 3 fulltime CYA and 4 fulltime prison positions. Commissioner Parsons moved to approve. Commissioner Yoder seconded. The motion carried unanimously.
